4. College of Direct Supports	Cindy Wickline, with Cardinal Innovations gave a presentation on College of Direct Support, a free training available to Providers on line. (Handout) Three MCO's, Cardinal, Smoky Mountain, and Trillium are collaboratively working together in a workforce development initiative that will provide free training for our network providers direct care staff and their supervisors. This training is designed to increase the knowledge, skill set, and competencies of our direct support staff; therefore, improving the quality of services to members and producing positive outcomes. The DirectCourse training is aligned with the Centers for Medicare and Medicaid (CMS) competencies in the NC Innovations waiver. Included in the packet is a CMS Core Competency Cross Walk. Cardinal's initial focus will be our IDD providers, with anticipation of expanding. Credits earned will contribute toward staff's certification. All courses are web based Agencies should go ahead and decide which courses they want their staff to take and have their point person contact Kimberly Knotts, DirectCourse System Administrator at 704.986.7291.
